About Us

Based on Isle of Bute and with a remit to delivery services across Argyll & Bute, Fyne Futures is a registered charity and established social enterprise. It is a subsidiary of Fyne Homes Ltd, a housing association with a focus on community regeneration and environmental sustainability. Fyne Futures board is independent from Fyne Homes and are fully responsible for good governance delivery of our charitable objectives¹. Our volunteer board currently has 9 members of which 8 are resident to Bute. The board has a wide range of experience and expertise – from private, public and third sectors.

Since 2005, Fyne Futures has been delivering a range of carbon saving services and produce including recycling, reuse, local produce and community car club with associated social and environmental benefits to Bute and beyond. Fyne Futures have successfully delivered a series of projects through funding from various sources, including several from our current project funder Climate Challenge Fund. Fyne Futures actively collaborates with other community organisations to achieve greater impact, and will do so to deliver the wider Bute Carbon Free Families project. The Walking Food Trail is part of this project and the key stakeholders would include but are not limited to: local food producing businesses, Climate Challenge Fund, Fyne Futures and board of directors.

Background

The project community is the Isle of Bute. This island has circa 6,410 residents – around 60% reside in the main town of Rothesay, whilst the remaining 40% reside in the village of Ardbeg, remote rural villages Port Bannatyne, Kilchattan Bay or remote rural settlements on West Coast of the island and farmsteads.


The Overall Purpose for this Walking Food Trail project -

¹ Appendix 1

Aims and Objectives

- To deliver a visual aid- a series of postcards featuring images of Rothesay that represents local food growing and local business.
- To increase awareness of free food in community spaces

Images may be created in any chosen medium, but they must be reproducible in a flat, colour A6 size. They may for example be photograph, painted, hand drawn etc.

The submitted images must be a series of no less than 8 and no more than 10 images reflecting the free local food grown in Rothesay and local businesses retailing in Rothesay.

The intended route for the food trail is to be between Chapel Hill Accessible Gardens and Battery Place. The trail should pass local food retailers and businesses growing free food for others. It should include the following sites:

- 1. Chapel Hill Raised bed Garden
- 2. Raised bed growing area on corner between Ladeside Place and Ladeside Street
- 3. Raised bed triangles on pathway adjacent to Columshill place
- 4. Raised bed sheltered gardens, Union Street next to Rothesay Nursery
- 5. Raised beds on corner of Russell Street and High Street
- 6. Guilford Square Fruit Trees in half barrels
- 7. Battery Place raised beds

Submissions must include a minimum of at least one image of each of the above sites but can do so in any order, providing it begins and ends in the key areas 1. & 7.

All images submitted must be limited to Rothesay, as the aim of the project is to create a short walking trail within the town.

As it is part of a walking tour, the images can include a map or description of route/location.

These final images will be provided to Fyne Futures no later than 1st September 2019. Licence to reproduce these images will be solely given to Fyne Futures with the artist being given credit for this work.

Development and inception phase

We are seeking to appoint a partner to produce a series of images in a 2D format. It is expected that the successful applicant will attend an inception meeting upon appointment. We expect the applicant to be able to submit a draft of their work for feedback in the first instance before the appropriate deadline, with the final piece returned no later than the submission deadline.
